

## **Our demands in addition to the demands of the Farmers and the Public**

### **1. Our demands:-**

#### **1. Abolish Income tax:**

- Every citizen will be tension free and fear less.
- Interest rate will become zero on bank deposit.
- All financial products will be no more and investment avenues will become zero.

#### **2. Loan to everyone @0.01% p.a. interest easily (Interest of Rs.1000 in a year on a loan of Rs. 1 crore):**

- Who is having caliber or capacity or potential or qualification or any special feature?
- It will result into various multifarious job and other opportunities.
- It will improve collection of taxes manifold.

#### **3. Only three taxes - Excise, Sales tax and Service tax :**

- A maximum rate of 10% on any tax.
- Progressive tax – A boon for the beginners.
- Other than the above three taxes, there should not be any tax of any sort in the country.

#### **4. Limit of Income:**

- Minimum salary should be Rs. 5000/- and maximum Rs. 5 Lac p.m.,
- Minimum pension should be Rs. 5000/- pm to everyone after the age of 60 years.
- Minimum unemployment allowance should be Rs. 5000/- pm.

#### *Notes:*

1. **About value of money** :- Within one year of its implementation one Rupee will be equal to one Dollar, Rs.5000 will have substantial value.
2. All products and services will be cheaper.
3. To make the provision of one time food in a day free, for that in cities, women and unemployed youth should get Rs. 3000/- pm and in villages Rs. 2000/- pm
4. Employees and permanent workers should get a pension @2.5% of every year completed or 50% of last salary drawn whichever is more.
5. Those employees who retired long back, they should get the pension what a person is getting in the same rank at present i.e. One Rank One Pension (OROP).
6. All temporary teachers should be made permanent at a respectable salary.
7. *Aanganwadi* workers and health workers should be made permanent at a respectable salary.

8. A special provision (for rehabilitation, employment, pension, housing and to get them a respect in the society) for transgender/*hijdas* and prostitute should be made.
9. A special provision should be made for dry toilets workers and to provide scavengers of gutters/sewage with latest machines and equipments.

**5. Limit of Assets:**

- Property-One house/shop/agricultural land within 25km aerial distance.
- Jewellery- For a female 200gm/a male 50gm.
- Diamonds- For a female 5 carat/a male 1 carat.
- Car- One for a family of up to 5 members and Business car should be a separate.
- Cash- Rs. 10,000/- per person in coins.  
(It will help a person to keep everything the best, on the basis of one's caliber and potential as there will be no scope to invest money.)

**6. Unlimited Bank balances subject to Equalization tax:**

- A miraculous tax for leaps and bounds progress of the country.

**7. Police Reforms:**

- Working hours should be 28 in a week.
- Salary should be double.
- Anyone having stomach outside his belt should resign.  
(A reasonable time should be allowed to improve one's health)

**8. Judiciary Reform:**

- A High court bench should be there in every 5 districts and a Supreme Court bench in every 5 states (it will help in consuming less time and less expensive).
- Time bound justice. Maximum time for any case in any court should not be more than 6 months or 6 hearings, whichever is earlier.
- All old cases should be closed.

**9. Political Reforms :**

- Election of Prime Minister (P.M.) and Chief Minister (C.M.) should be directly by the public.
- Pension of Member of Parliament (M.P.) and Member of Legislative Assembly (M.L.A.) should be equal to their salary and should not have any other source of income.
- Anyone (self, spouse or minor children) having any immovable property, that should be donated to the country.  
(It will provide entry to only those politicians, who really wish to serve the nation)

### **To support this system:**

- Coins should be in circulation instead of currency notes. (It will help in eradication of corruption)
- Other than Police and Army, anyone keeping arms and ammunition should be treated as a traitor. (This provision in addition to the above provision related to coins will help in eradication of terrorism to a great extent)
- Any person involved in drugs or adulteration or arms and ammunition or encouraging caste differentiation or dealing with professional blood donors / trading in human organs, the process should be completed within 5 weeks by all the 3 courts and in 6<sup>th</sup> week, penalty should be executed.

### **2. Demands of the farmers :-**

- **All loans of any sort (100%- from financial institutions and money lenders ) should be waived off fully.**
- **MSP (Minimum Support Price) should be raised by minimum of 50%**

### **3. Demands of the public :-**

- Every citizen of the country should get food, clothing, housing, education, health services, security, water, electricity and transport easily.
- Guarantee of livelihood for every student, laborer, farmer, employee and businessman/self employed.
- A special arrangement should be made for the disabled (orphans, old and handicapped & their parents). For disabled a home should be built in every block of villages and city, where all of them can live together in a separate wing of the same complex with all the modern facilities free, which are required by them for better life and rehabilitation. Above all, to end all the questions arising in the mind of the parents of such children that what about these children after their death and many more?
- It should be the responsibility of the government to check, as happening in the prices of pulses. Retail prices of pulses are very high and farmer is not getting anything, so that exploitation and undue advantage may end.
- To do all the acts which are required to make our country Hindustan a Heaven i.e. in a span of one year of its implementation one Rupee may be equal to one Dollar and in ten years may be equal to 100 Dollar. Government will never be having paucity of funds may be say Rs. 10/20/50/100.....1000 lac crore as money borrowed by the government will be mere book entry only, which will be never payable.
