

How Poverty, Corruption and Terrorism can be eradicated from the country?

Reasons of Poverty: Unequal income and unequal wealth. Both of these should be available to a person on the basis of one's caliber and potential. But the person who is lacking these, he should also get food, clothing, housing, education, health services, security, water, electricity and transport easily.

To eradicate poverty the following provisions should be made:-

1. Limit of Income:-

- Minimum salary should be Rs. 5000 p.m. and maximum Rs. 5 lac p.m.
- Minimum pension should be Rs. 5000 p.m.
- Minimum unemployment allowance should be Rs. 5000 p.m.
(There should not be any limit for the profits and dividend)

2. Limit of Property:-

- One house and/or shop or agricultural land within 25 k.m. aerial distance.
- Limit of Jewellery – For a female – 200 gram and for a male – 50 gram.
- Limit of Diamonds – For a female – 5 carat and for a male – 1 carat.
- Car – One for a family of up to 5 members Business car should be a separate.
- Cash – Rs. 10000 per person and that too in coins.

3. Bank Balances:-

Unlimited subject to an Equalization tax. This is a revolutionary tax which has not been applied in any of the part of the world. But the country who will apply this tax will progress not by leaps and bounds but boundless.

Reasons of Corruption:- Easy keeping, handling and transportation of money on one hand and on the other side complicated and inhuman tax laws, as well as state of mind of the citizens of the country.

To eradicate corruption the following provisions should be made and implemented:-

1. Coin should be in circulation in place of currency notes. Any person who is keeping more than Rs. 10,000/- in cash / coins should be treated as a traitor and penalty should be 10 years imprisonment of *Kala Pani* (*Kala Pani* – should be sent the farthest up to 5,000 k.m. and no known person should be allowed to meet.)
2. To simplify tax laws and to keep reasonable tax rates
3. Till coins are in circulation, a provision should be made that in any government office, an employee or a visitor is having cash more than Rs. 2000/- should be treated as traitor and penalty should be imposed as given above in point number 1.

By circulation of coins it will become difficult to keep, carry and transport money by which state of mind of the citizens will also change gradually.

Reason of Terrorism: Main reason of terrorism are easy keeping, handing and transportation of money, availability of arms and ammunition and state of mind of a person.

To eradicate terrorism the following provisions should be made:-

1. Anyone keeping arms and ammunition (other than by Police and Army) should be treated as a traitor and penalty should be death only. When no one will be having arms and ammunition in the country, automatically security of every citizen will improve.
2. By circulation of coins and fixing its limit, keeping, handling and transportation of money will also become difficult.
3. By implementation of the above provisions and with the passage of time state of mind will also change.

If you wish to build our country Hindustan a Heaven, it is essential to eradicate poverty, corruption and terrorism from the country as mentioned above.
